The “**Securities and Exchange Commission**” (SEC) provided regulations concerning the requirements of reporting and publication of “**Conflict Minerals**”, according to the “Dodd-Frank Wall Street Reform and Consumer Protection Act” of 2010.

Section 1502 of the Act defines the reporting obligations for companies that are publicly traded in the US and are governed by the Securities & Exchange Commission (SEC). Section 1502 requires companies that make products for which 3TG minerals (tantalum, tin, tungsten and gold) are necessary to the functionality or production of that product to assess their supply chains and publically report on the source of these minerals if they are sourced from the Democratic Republic of Congo (DRC) or adjoining country or if they are from recycled or scrap sources.

Although P.G.A. srl is not a publically traded company, and therefore not directly subject to this law, we provide this declaration to our downstream customers to help them comply with any obligations relative to this law.

P.G.A. srl supports the fight against violence, violation of human rights, and deterioration of the environment for the mineral processing and trading of some minerals (gold, tin, tantalum and tungsten, derivative of cassiterite, columbite-tantalite and wolframite) in the geographic area defined “**Conflict Region**”, including the Republic of Congo (RDC) and the adjoining Countries.

P.G.A. srl does not directly acquire minerals from smelters or mines but is taking and will take due diligence within our supply chain to assure “DRC Conflict-Free” for the metals of gold (Au), tantalum (Ta), tungsten (W), cobalt(Co) and tin (Sn) are not derived from or sourced from mines in conflict areas of the Democratic Republic of Congo (DRC), or illegally taxed on trade routes, either of which are controlled by non-governmental military groups, or unlawful military factions.

Trade routes not confirmed to be “Conflict Free” include direct exports from the DRC, as well as exports through Rwanda, Uganda, Burundi, Tanzania and Kenya (Countries of whom the U.N. Security Council note are global export routes for DRC-mined minerals).





In any materials, part or compounds used by P.G.A. srl, should the use of minerals produced in facilities considered **“Non-Conflict Free”** be verified, P.G.A. srl undertakes to adopt appropriate actions in order to make the product **“Conflict Free”**.
